

Thank you for your interest in being a chaperone for Rock the Mall with GSOH! This is an amazing opportunity for our girls that requires the help of adult volunteer chaperones. If you are interested in helping girls celebrate the 100<sup>th</sup> anniversary of Girl Scouting in Washington D.C. at the Rock the Mall Sing-Along, this opportunity is for you! Join us as we ROCK THE MALL and see the sights in Washington D.C.!

Chaperones will pay \$175, half-price, for the trip. Chaperones will be assigned a bus and group of girls for the trip. Chaperones will be responsible for carrying the proper paperwork and supervising the girls in their group. Chaperones will NOT be able to choose the girls in their group. Chaperones must be First Aid/CPR certified, at least 25 years old, and a registered volunteer with a completed background check. A mandatory meeting for chaperones will be held prior to the trip.

Chaperones are required to fill out the following application and submit it to the Mansfield Service Center by March 13, 2012 to be considered. Notifications will be made to chaperones beginning in February. The number of chaperone spots available depends on number of girl participants. Applying does not guarantee a chaperone position.

Note:	Deposit is applied toward event fee.
